	The following questions were received:
. Quest	We can try to get the full breakdown as requested here, but at time of closing it is almost impossible, which is why we provided our pricing with the boxes crossed off.
Reply	Documentation, such as the Revised Pricing Schedule A, shall be submitted as requested in the tender document.
Quest	item #3 is tricky to price on its own, generally just part of our general conditions. We don't put specific prices on these, we just include it as part of our project management costs overall.
Reply	The decision to isolate item#3 of the Pricing Schedule A is to intentionally highlight its importance to the City of Clarence-Rockland.
Quest	ion: Items 5-7 would often be a single lump sum (maybe item 7 on its own).
Reply	The City of Clarence-Rockland is seeking separate pricing for items 5, 6 and 7.  A Revised Pricing Schedule "A" is attached to addendum #2 and its intent is to clarify the format of the unit price for item #6. Please use the Revised Pricing Schedule "A" for your tender submission.
Quest	ion: Items 10-14 would be priced as a single lump sum by our steel trades.
Reply	The City of Clarence-Rockland is seeking separate pricing for items 10, 11, 12, 13 and 14.  Please note that provisional items will be selected at the time of contract award and are dependent on budget availability.
Quest	ion: Items 15-18 would be a single lump sum by roofing trades.
Reply	The City of Clarence-Rockland is seeking separate pricing for items 15, 16, 17 and 18.
Quest	ion: Item 19 could be put in with item 8 as a single lump sum.
Reply	The City of Clarence-Rockland is seeking separate pricing for items 8 and 19.
Quest	ion: Items 22 and 23 typically a single lump sum from a door supplier, plus the cost of glass units from another supplie
Reply	The City of Clarence-Rockland is seeking separate pricing for items 22 and 23.  Please note that provisional items will be selected at the time of contract award and are dependent on budget availability.
